

**LIMITED PROXY**

KNOW ALL MEN BY THESE PRESENTS:

Vote for only one (1):

**A. RESERVES**

**NOTE: WAIVING OF RESERVES, IN WHOLE OR IN PART, OR ALLOWING ALTERNATIVE USES OF EXISTING RESERVES MAY RESULT IN UNIT OWNER LIABILITY FOR PAYMENT OF UNANTICIPATED SPECIAL ASSESSMENTS REGARDING THOSE ITEMS.**

- Vote in favor of collection of all statutory reserves in accordance with §718.112(2)(f), F.S., such that all statutory reserves shall be collected in the 2011 budgetary year. **(This would result in a substantial increase in all unit owners' monthly maintenance assessment obligation.)**
- Vote in favor of partially waiving the collection of all statutory reserves in accordance with §718.112(2)(f), F.S. (in an amount to be determined by the Board of Directors), such that only a portion of statutory reserves shall be collected in the 2011 budgetary year. **(The Board of Directors of your Association strongly recommends this option; no increase in the monthly maintenance/reserve assessment obligation.)**

**B. TERM OF DIRECTOR'S SERVICE**

- Vote in favor of amending §4.4 of the By-Laws to provide that the term of each Director's service shall be for a two (2) year period.
- Vote against amending §4.4 of the By-Laws to provide that the term of each Director's service shall be for a two (2) year period.

The undersigned ratify and confirm any and all acts and things that the proxy may do or cause to be done in the premises, whether at the meeting referred to above or at any change, adjournment, or continuation of it, and revoke all prior proxies previously executed.
